Dear JROTC Cadets and Parents,

Well, the AFJROTC Summer Leadership School (SLS) will be beginning before we know it and as we promised enclosed are additional details about what we will be doing and also various forms that the county requires that you fill out before you will be able to attend the camp. First for the details:

- a. Attachment 1 provides the SLS Operating Policies and Procedures which will be the guidelines used to ensure efficient and effective training during the week.
- b. Attachment 2 provides a tentative SLS schedule by day for your information. As you can see we will keep the students very busy. Much of what we will be doing will be somewhat physical. Make sure you have some good running shoes so you don't get shin splints or any other ailments. Parents, if your student has any medical problems or is required to take any medication, please indicate this on the back of the Overnight Trip Form (Attachment 4) so we can take the necessary precautions. Don't forget, cadets need to report to the ROTC room at Buchholz at 8:00 AM each morning and will be release at 5:00PM.
- c. We want all the students to be fitted for their uniforms. We are using Monday, 11 August to fit out our first year cadets. We are coordinating with Lili's Alterations to have a seamstress here to measure pants so we can have them altered and back to the cadets hopefully by midweek.
- d. Those cadets who have not paid the \$75 for the camp need to send or bring the balance to us on or before 31 July 2014.

Now for the paperwork part:

- a. Attachment 3 is a **Cadet Contract, please read and sign (student and parent)**.
- b. Attachment 4 is the **BHS Parental Trip Permission for Overnight Trip Form**. Even though this is not an overnight school, this form is essential to ensure prompt and proper action in the unlikely case of a medical emergency. Please be sure to complete the medical and insurance information on the back of the form as completely and accurately as possible.
- c. Attachment 5 is the **Health Screening Questionnaire** which is required for cadets to participate in physical training activities not only at SLS but also throughout the school year.
- d. Attachment 6 is the **FL-821 AFJROTC Blanket Parent Permission Form**. This form provides approval for cadets to participate in regularly scheduled activities throughout the school year. This is not a complete listing of activities. For activities not listed, a separate permission form will be provided prior to the event.

Sorry for all the paperwork, but the county requires all of it for students to participate in such activities.
